NO:GH/SH/ $\Im 2$ /2015/SCT/132001/2276/GH - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend Principal, Class I, in the Government Polytechnics (Collegiate Branch), Recruitment Rules, 2014, namely:-

- These rules may be called the Principal, Class I, in the Government Polytechnics (Collegiate Branch), Recruitment (Amendment) Rules, 2015.
- 2. In the Principal, Class I, in the Government Polytechnics (Collegiate Branch) Recruitment Rules, 2014, (herein after referred to as "the said rules") in clause (ii) of sub rule (a) of rule 2, the following shall be substituted namely:-

"possess a Ph.D. degree of Engineering or Technology of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed University under section 3 of the University Grants Commission Act, 1956 and recognized by the All India Council for Technical Education."

3. In the said rules, in rule 8, in the second line the words "or Gujarati" after the word "Hindi" shall be added.



CONSTITUTION OF INDIA NO.GH/SH/.2.3/2014/SCT/132001/2276/GH:-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Principal, Class I, in the Government Polytechnic in Gujarat Educational Service, (Collegiate Branch) under the Commissionerate of Technical Education, Gujarat State, namely-

- 1. These rules may be called the Principal, Class I, in the Government Polytechnics (Collegiate Branch) Recruitment Rules, 2014.
- Appointment to the post of the Principal, Class I, in the Government Polytechnics in Gujarat Educational Service, (Collegiate Branch) shall be made either,
 - (a) by promotion of a person of proved merit and efficiency having "Very Good" bench mark for being considered fit for promotion as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who-
 - (i) have worked for not less than five years in the cadre of the Head of Department, in the Government Polytechnics in the Gujarat Educational service, Class-I (Collegiate Branch) in engineering or technology; and
 - (ii) possess a Ph.D. degree in Engineering or Technology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as

such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification and recognised by the All India Council for Technical Education;

(iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reason to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

- (b) by direct selection;
- 3. Appointment by direct selection and promotion shall be made in the ratio of 1:1.
- 4. To be eligible for appointment by direct selection to the post mention in rule 2, a candidate shall,-

(a) not be more than 45 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(b) possess a Bachelor's and Master's degree of appropriate branch in Engineering or Technology with first class or equivalent either at Bachelor's or Master's level and Ph.D. or equivalent, in appropriate discipline in Engineering or Technology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; and

- (c) have about ten year combined or separate experience in teaching or research or industry out of which atleast three years experience on the post of the Head of Department, Class-I in the Government Polytechnics or on the post which can be considered equivalent to the post of Head of Department, Class-I in the Government Polytechnics;
- (d) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
- (e) possess adequate knowledge of Gujarati or Hindi or both.

Explanation:

(i) In case of research experience, good academic record and books/research paper publication/ Intellectual Property Right (IPR) patents record shall be required as deemed fit by the Gujarat Public Service Commission.

(ii) If the experience in industry is considered, the same shall be at managerial level which can be considered equivalent to the post of Head of Department, Class-I in the Government Polytechnics with active participation record in designing, planning, executing, analyzing, quality control, innovating, training, technical books/research paper publications/ IPR patent, etc. as deemed fit by the Gujarat Public Service Commission.

(iii) Equivalence for Ph.D is based on publication of 5 international journals having a cumulative impact index

of not less than 2.0, with incumbent as the main author and all 5 publications being in the author's area of specialisation.

(iv) Experience at diploma institution is also considered equivalent to experience in degree level institution at appropriate level as applicable.

(v) If a class/division is not awarded, minimum aggregate 60 per cent marks shall be considered equivalent to first class/division.

(vi) If a grade point system is adopted, the Cumulative Grade Point Average (CGPA) shall be converted in equivalent marks as below:-

Grade point	Equivalent percentage
6.25	55%
6.75	60%
7.25	65%
7.75	70%
8.25	75%

- 5. The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidates appointed by direct selection shall, during his probation period be required to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-service Training Examination Rule, 1970.
- 7. The candidate appointed by direct selection shall during his probation period be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 8. The candidate appointed by direct selection shall be required to pass an examination in Hindi or both in accordance with the rules prescribed by the Government.

9. The candidate appointed either by direct selection or by promotion shall have to undergo such training and pass

such examination as may be prescribed by the Government.

10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and such period as may be prescribed by the Government.
